

## Auto insurance rates for third quarter 2000

Ontario private passenger auto insurance rates rose during the quarter ending September 30, 2000.

The rates approved during the third quarter of 2000 indicate an increase of 3.49 per cent in auto insurance rates when weighted by market share.

The last increase (0.87 per cent) occurred during the quarter ending June 30, 2000.

FSCO will continue to ensure that insurers' rate changes are reasonable and justified and that the rates that insurers charge are balanced with their ability to meet their future claims costs.
